The price in U.S. Dollars per Metric Ton DAP (Delivery At Place) one or more safe port(s)/ berth(s) Lebanon, based on the received quantity, will be equal to: The average of all the means of the high and the low quotations for Fuel oil 1.0 % as published in Platts European Marketscan under the Heading “**FOB Med (Italy)**” plus a premium of U.S. Dollars /..... / (By numbering) PMT U.S. Dollars ..... (By lettering) per Metric Ton.

The quotations to be taken into consideration will be the effective and valid published quotations on the Bill of lading (B/L) date, the five (5) published quotations immediately before and the five (5) published quotations immediately after. In case no quotation on B/L date then the five (5) quotations before and the five (5) quotations after Bill of lading date to apply (total 10 quotations).

The received fuel oil quantity is the outturn quantity net in air received at the shore tanks in Lebanon.

The cost of each additional port of discharge in Lebanon will be an additional extra premium of U.S. Dollars /...../(By numbering) PMT U.S. Dollars/...../(By lettering) per Metric Ton.

The Bidder may notice lowering the average of all the means of the high and the low quotations mentioned above, before adding the premium, and his offer will be accepted. Knowing that the amount of lowering should be mentioned in the absolute value, and not as a percentage discount rate on same average of all the means of the high and the low quotations.
