**Clarification #2 on queries raised by bidders.**

In response to request of clarification raised by the bidders, please note the following:

1-

سؤال: هل بإمكاننا الإستعاضة عن الكفالة المطلوبة بشيك Fresh USD cheque bancaire ؟

Reply: yes a cheque bancaire in Fresh USD can replace the bid security.

2-

سؤال: هل بإمكاننا الإستعاضة عن إفادة من إفادات حسن التنفيذ (متعلقة بأعمال steel work construction بصورة عن العقد مع صور عن الكشوفات النهائية تثبت تنفيذ الأعمال المطلوبة وبالمبلغ المطلوب؟

Reply: ITB5.1(x) list the required documents related to the projects certificates. Regarding the performance guarantee, refer to the condition iii) of this clause.

iii) A certificate issued by the bank issuer of the good performance guarantee of the project acknowledging the issuance of the said guarantee and stating the guarantee number, its purpose, value, and validity, along with a copy of the said guarantee. **This certificate is not required whenever the project is executed by a Lebanese Ministry or a Lebanese Public Establishment. For projects not requiring a performance guarantee, the bidder shall furnish the document evidencing that the relevant stamp duty has been duly collected shall be furnished.**
