ADDENDUM No.1

TO THE CONTRACT No. 21003

This Addendum no.1 (hereinafter together with all Annexes attached hereto and forming an integral part hereof, called the "Addendum") is made the 24th of February 2025, between, on the one hand, the **Council for Development and Reconstruction** (hereinafter called the "Client") and, on the other hand, **Mr. Rony Nassar** (hereinafter called the "Consultant").

WHEREAS

- (A) the Client has implemented the *Lake Quaroun Pollution Prevention Project* funded by the World Bank (Loan no. 8637-LB), (hereinafter called the "Project"),
- (B) on the 21st of March 2024, the Client has signed a Contract with the Consultant concerning Services required for the Project as *Procurement and Contract Associate*, (hereinafter called the "Contract no.21003") in accordance with CDR Board of Directors decision no.50/2024/A dated 1/2/2024 (item2),
- (C) the Client has requested the Consultant to continue the Services required for the Project according to CDR Board of Directors decision no.551/2024/A dated 18/12/2024,

NOW this Addendum no.1 witnesseth as follows:

- 1- In this Addendum, words and expressions shall have the same meanings as are respectively assigned to them in the Contract.
- 2- The following documents shall be deemed to form and be read and construed as part of this Addendum, in the order of precedence as set out below:
 - a) this Addendum no.1,
 - b) the Financial Details (Annex A),
 - c) the Conflict of Interest Certificate (Annex B)
 - d) the Contract no.21003
- 3- The period of this Addendum shall be (11) months starting from 1/1/2025 till 30/11/2025.

4- The total amount of this Addendum is U.S\$26,400.00 (twenty six thousand four hundred United States Dollars) including all taxes and duties, as specified in Annex A.
This amount shall be paid on equal monthly installments amounting U.S\$2,400.00.

5- As stipulated in article (5) of the banking secrecy law dated 3/9/1956 and as stipulated in the resolution of the Council of Ministers no.4 dated 28/4/2020, the Consultant agrees to lift banking secrecy over the bank account used to deposit or transfer public funds related to this Contract.

6- The Consultant is entitled to (14) days vacation leave.
The Consultant is not allowed to carry over an accumulated vacation leave considering that this leave shall be invalid at the end of the contractual period specified in this Addendum.

7- The Consultant shall benefit from (11) days as sick leave provided that the Consultant shall submit a medical report within a period not exceeding (2) days of absence.

8- The Consultant shall permit the Bank and/or persons or auditors appointed by the Bank to inspect and/or audit its accounts and records and other documents relating to performance of the Contract. Any failure to comply with this obligation may constitute a prohibited practice subject to contract termination and/or the imposition of sanctions by the Bank (including without limitation a determination of intelligibility) in accordance with prevailing Bank's sanctions procedures.


9- The terms and conditions of the Contract no. 21003 which are not modified by this Addendum apply accordingly.

10- The two Parties shall sign this Addendum in admission of compliance with its provisions.


