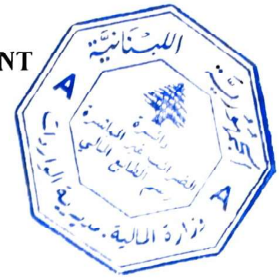

ADDENDUM No.1

TO THE CONTRACT No. 21067



This Addendum no.1 (hereinafter together with all Annexes attached hereto and forming an integral part hereof, called the "Addendum") is made the 9th of October, 2025 between, on the one hand, **the Council for Development and Reconstruction** (hereinafter called the "Client") and, on the other hand, **Mr. Haitham Nemer** (hereinafter called the "Consultant").

WHEREAS

- (A) the Client has implemented the "*Improvement of Wastewater Management and Sanitary Services in Al-Ghadir Basin*", as defined hereinafter (hereinafter called the "Project");
- (B) on the 5th of September 2024, the Client has signed a Contract with the Consultant concerning Services required for the Project, as **Project Coordinator**, (hereinafter called the "Contract");
- (C) the Client has requested the Consultant to continue the Services required for the Project according to CDR Board of Directors' decision no. 318/2025/A dated 24/7/2025;

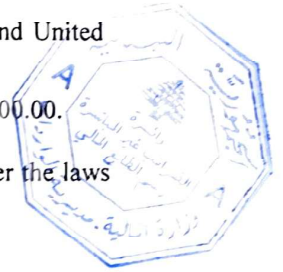
NOW this Addendum no.1 witnesseth as follows:

- 1- In this Addendum, words and expressions shall have the same meanings as are respectively assigned to them in the Contract.
- 2- The following documents shall be deemed to form and be read and construed as part of this Addendum, in the order of precedence as set out below:
 - a) this Addendum no.1,
 - b) the Financial Details (Annex A),
 - c) the Contract no.21067.
- 3- The period of this Addendum shall be (11) months starting from 5/8/2025.

- 4- The total amount of this Addendum is **U.S.\$33,000.00** (thirty three thousand United States Dollars) excluding all taxes and duties, as per Annex A.

This amount shall be paid on equal monthly installments amounting U.S.\$3,000.00.

The Consultant shall pay all taxes, duties and charges imposed on him under the laws of the Republic of Lebanon.

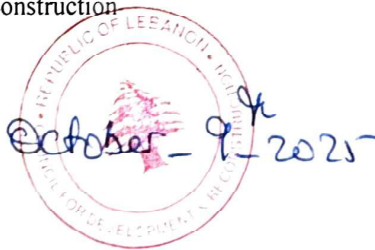


- 5- As stipulated in article (5) of the banking secrecy law dated 3/9/1956 and as stipulated in the resolution of the Council of Ministries no.4 dated 28/4/2020, the Consultant agrees to lift banking secrecy over the bank account used to deposit or transfer public funds related to this Contract.
- 6- The Consultant is entitled to (14) days vacation leave.
The Consultant is not allowed to carry over an accumulated vacation leave considering that this leave shall be invalid at the end of the contractual period specified in this Addendum.
- 7- The Consultant shall benefit from (11) days as sick leave provided that the Consultant shall submit a medical report within a period not exceeding (2) days of absence.
- 8- The terms and conditions of the Contract no.21067 which are not modified by this Addendum apply accordingly.

IN WITNESS whereof the Parties hereto have caused this Addendum no.1 to be signed in two original copies of which each party keeps one, in their respective names as of the day and year and first above written.

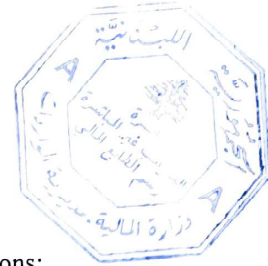

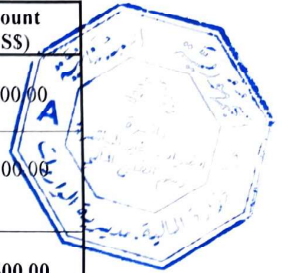
