The Lebanese Republic (hereinafter called "Borrower") has applied for financing in the amount of 250 million US Dollars from the International Bank for Reconstruction and Development (IBRD) (the "Bank") in the form of a "loan" (hereinafter called "loan") toward the cost of Lebanon Emergency Assistance Project. The Council for Development and Reconstruction (CDR), an implementing agency of the Client, intends to apply a portion of the proceeds of this loan to eligible payments under the contract for consulting services to be procured under this project.

The consulting services include providing support to the CDR as a Project Coordinator at the Ministry of Public Works and Transport under the project.

The Council for Development and Reconstruction (CDR) is in the process of establishing a project management unit to assist The CDR in the implementation of the Lebanon Emergency Assistance Project (LEAP), now invites eligible local experts ("Individual Consultants"), to indicate their interest in providing the required Task. Interested individuals should provide information demonstrating that they have the required qualifications and relevant experience to perform the Tasks by submitting their Expression of Interest ("EOI") and Curriculum Vitae ("CV") as per attached CV format. The shortlisting criteria are:

1. Minimum bachelor's degree in civil engineering (B.E). A master's degree in a relevant field is an advantage.
2. Minimum of 20 years of relevant experience and at least 10 years of experience in infrastructure project management with public authorities.
3. Demonstrated experience working with & preferably within public sector institutions, preferably at the Ministry of Public Works in Lebanon.
4. Working knowledge on projects funded by International Financial Institutions (e.g., World Bank, ISDB, EIB, etc.).
5. Familiarity with infrastructure recovery, post-conflict reconstruction, and/or emergency response is highly desirable.
6. Must have Strong project coordination and organizational skills.
7. Excellent communication and interpersonal abilities, with the capacity to work effectively across institutions and with diverse stakeholders.
8. Strong technical reporting, planning, organizational and coordination skills.

- 9. Knowledge of procurement, environmental/social safeguards, and monitoring and evaluation principles is a plus.
- 10. Proven experience in MS Excel, PowerPoint, Acad is a must.
- 11. Fluent in English and Arabic (written and spoken). French is a plus.
