Assignment Title: Senior Procurement Expert

The Lebanese Republic (hereinafter called "Borrower") has applied for financing in the amount of 250 million US Dollars from the International Bank for Reconstruction and Development (IBRD) (the "Bank") in the form of a "loan" (hereinafter called "loan") toward the cost of Lebanon Emergency Assistance Project. The Council for Development and Reconstruction (CDR), an implementing agency of the Client, intends to apply a portion of the proceeds of this loan to eligible payments under the contract for consulting services to be procured under this project.

The consulting services include providing Procurement support to the CDR as a **Senior Procurement Expert** under the project.

The Council for Development and Reconstruction (CDR) is in the process of establishing a project management unit to assist The CDR in the implementation of the Lebanon Emergency Assistance Project (LEAP), now invites eligible local experts ("Individual Consultants"), to indicate their interest in providing the required Task. Interested individuals should provide information demonstrating that they have the required qualifications and relevant experience to perform the Tasks by submitting their Expression of Interest ("EOI") and Curriculum Vitae ("CV"). The shortlisting criteria are:

Qualifications Requirements:

- Minimum Bachelor Degree in Engineering (B.E.), Business or equivalent degree.
- Master Degree is a plus.
- Minimum of 20 years' experience in formulation, review and training related to tender documents (Works, goods, etc...) and Request for Proposals for Consultancy Services (Time based and Lump-Sum), including draft contract special/particular Conditions, in the design and/or management/supervision of infrastructure projects.
- Must have excellent management skill.
- Must have extensive experience in FIDIC Contract or similar contract conditions under projects financed by at least one international financial institution (World Bank, EIB, IsDB, etc). Experience with WB procurement guidelines is a plus.
- Must have extensive experience in procurement services as per international procurement regulation, as evaluation of Consultants and Contractors for infrastructure projects and Project tender documents and evaluation of RFBs Works & Goods with rated criteria.

It is preferable to limit the EoI to a maximum of 10 pages including the CV as per attached CV format. Pages beyond 10 will not be reviewed.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank’s “Procurement Regulations for IPF Borrowers for Goods, Works, Non-Consulting services” dated February 2025 (“Procurement Regulations”), setting forth the World Bank’s policy on conflict of interest.

Shortlisted Consultants will be invited for interview, upon which a Consultant will be selected for negotiation in accordance with the Individual Consultant Selection described in the “World Bank Procurement Regulations for IPF Borrowers.

The Deadline for receiving EOIs is to be on **Thursday September 4th, 2025** at 12:00 o’clock noon Beirut local time.

I- Introduction

As Lebanon emerges from the 2023-24 conflict and overlapping multifaceted crises, the proposed emergency Project supports the most urgent repair and reconstruction of damaged critical infrastructure and lifeline services and the sustainable management of rubble. Given the magnitude of the needs, estimated at approximately \$11 billion, the Project establishes a robust, transparent, and data-driven framework to identify and execute priority investments, restoring essential services where they are most urgently needed to resume social and economic activities. This framework will allow the Government of Lebanon (GOL) to seamlessly coordinate support for recovery and reconstruction as additional financing becomes available from partners. To enable the efficient delivery of the expected volume of investments in the years ahead in an accountable and transparent manner, reform measures and streamlined procedures have been identified to strengthen the Council for Development and Reconstruction (CDR) according to international benchmarks.

II- Project Background

The Proposed Project Objective is to enable sustainable recovery and restore lifeline services and critical infrastructure in conflict-affected areas of Lebanon.

The LEAP will support the GoL in a sequenced approach to response, recovery and early reconstruction. This will include improvements in the environmental management of rubble, restoration of lifeline services and critical infrastructure in prioritized areas affected by the conflict and support to the most vulnerable to undertake repairs to partially damaged housing. The Project will inform longer term reconstruction of damaged public buildings and infrastructure using a Build Back Better (BBB) approach to promote adaptation, sustainability, inclusion, and significant energy efficiency improvements and considering options for private sector financing. The four Project components are: (1) Immediate Response, (2) Lifeline Services and Critical Infrastructure Recovery; (3) Sustainable and Robust Reconstruction of Infrastructure and Lifeline Services; and (4) Project Management.

The LEAP is implemented by the Council for Development and Reconstruction (CDR) (hereinafter referred as Client) representing the Government of Lebanon (GOL) with expected funding support from the World Bank (WB).

III- Objective of the Assignment

The Council for Development and Reconstruction (CDR) intends to select a suitably qualified individual Consultant who will act as a **Full time “Senior Procurement Expert”**, in the Project Management Unit (PMU), to provide assistance to CDR during the implementation of the Lebanon Emergency Assistance Project.

IV- Scope of Work:

The scope of works entails the provision of a **Full Time - Senior Procurement Expert** consulting services for the Lebanon Emergency Assistance Project with the Council for Development and Reconstruction (CDR). The expected tasks within this scope will cover, but not limited to, the following tasks:

1. Undertake all procurement activities, such as preparation of bidding documents for works and goods, preparation of Request of Proposals (RFP) for Consultancy services, design and Supervisions.
2. Responsible of Tender launching, invitations, issuance of clarifications/amendments.
3. Evaluation of technical & financial proposals & bids and preparation of related reports.
4. Contract Preparation, Fund Confirmation.
5. Prepare the procurement plan
6. Responsible of managing all procurement activities in STEP.
7. Responsible for tracking the contract management module in STEP
8. Participate in the regular meetings with the Supervising Consultant, CDR, contractors, and other GoL staff.
9. Manage the project procurement through implementing all policies and procedures related to procurement activities and ensuring that Bank procurement regulations are followed in all transactions.
10. Participate in updating the Project Procurement Strategy for Development, as per project requirements.
11. Maintain the exchange between the project and the World Bank using the Systematic Tracking of Exchanges in Procurement (STEP).
12. Participate in project technical committees or component team meetings in order to ensure timely implementation progress with a focus on procurement-related activities.
13. Organize, plan, manage, and provide support to the preparation of all procurement activities.
14. Implement the planned activities either directly or by engaging the services of third-party suppliers/consultants/contractors/United Nations (UN) agencies/ Non-Governmental Organizations (NGOs).
15. Undertake necessary advertisement on annual and periodic basis.
16. Develop procurement documents and participate in the evaluation process for consultants, suppliers, and contractors (terms of reference (TOR) for consulting services, Technical specifications for Works and Goods, requests for proposals, request for bids, evaluation reports with recommendation for contract award, preparation of documentation for contract signing and payments, etc.).
17. Develop and maintain an updated Procurement Plan according to the project manual and standards and annual work plans for each component of the project. Coordinate with the Financial Officer and the Senior accountant for regular preparation of financial management reports, as a part of the World Bank financial reporting requirements. Integrate procurement planning and disbursement forecasts for realistic as per appropriate budget.

18. Establish, in coordination with financial and Information Technology (IT) teams, means for suitable internal control system to facilitate the process and monitoring procurement processing. Develop tools for capturing procurement data and identify progress towards the achievement of procurement schedules.
19. Lead development of procurement schedules and plans and generate regular updates for the guidance of the Project Manager, PIU team specialists and component team leaders
20. Conduct market research and update price lists in respect of relevant equipment, consultants, contractors.
21. Where international competitive procurement contracts estimated to cost at or above 10 million USD are foreseen, he/she shall undertake Early Market Engagement for each such contract. The plan and approach to Early Market Engagement shall be detailed in the PPSD. The planned approach should be appropriate for the type of procurement and operating environment
22. Develop and maintain a data base of suppliers, contractors and consultants to include their contacts, areas of expertise, relevance to project components. A cross reference system would be necessary to facilitate identification of filed supporting documents.
23. Maintain accurate procurement records, including all actions and documents for review by the World Bank's supervision missions. This includes advertisement, preparation of expressions of interest, TOR, request for quotations/proposals, proposals opening, evaluation of quotations/proposals, record of proposals submissions, contract award/purchase order, performance of the contracts, claims, complaints, reports, internal memos and correspondence related to procurement, and any relevant documents.
24. Ensure that all Consultants' deliverables are properly filed and referenced.
25. Participate in field visits to supervise works, executed works and delivered goods.
26. Collect information on acceptance of deliverables (works, goods, consultant's outputs).
27. Provide training on procurement related processing to procurement staff and other staff involved in procurement processing.
28. Facilitate post review and procurement audits on a random basis by the World Bank's supervision missions

V- Qualifications Requirements:

1. Minimum Bachelor Degree in Engineering (B.E.), Business or equivalent degree.
2. Master Degree is a plus.
3. Minimum of 20 years' experience in formulation, review and training related to tender documents (Works, goods, etc...) and Request for Proposals for Consultancy Services (Time based and Lump-Sum), including draft contract special/ particular Conditions, in the design and/or management/ supervision of infrastructure projects.
4. Must have excellent management skill.

5. Must have extensive experience in FIDIC Contract or similar contract conditions under projects financed by at least one international financial institution (World Bank, EIB, IsDB, etc). Experience with WB procurement guidelines is a plus.
6. Must have extensive experience in procurement services as per international procurement regulation, as evaluation of Consultants and Contractors for infrastructure projects and Project tender documents and evaluation of RFBs Works & Goods with rated criteria.
7. Fluent in Arabic and English; French is a plus.
8. Relevant software experience such Microsoft Word, Excel, and PowerPoint;

VI- Duration

The contract duration is 12 months. The contract is a Time Base contract subject to extension/renewal for the project duration upon mutual agreement, and strong performance of the Consultant.

VII-Administration and Reporting

The Consultant will report to the CDR, PMU Director.

The service under this TOR shall be performed at CDR offices in Beirut, with working hours from 8:00 am to 4:30pm from Monday to Friday, except official holidays.

The Consultant is allowed for a paid leave based on 1 day per month.

VIII- Remuneration

Billing and payments in respect of this service shall be made equally and on a monthly basis. The Consultant shall submit his/her invoice at the beginning of each month to cover the services submitted during the previous month. Noting that the total Consultant's remuneration (fees) shall include all communication fees, software, computers, and any Taxes at the home country of the Procurement Expert.

IX- Client's Responsibilities

CDR will provide all the necessary documentation and information that may be needed by the Consultant to fulfill his obligations. CDR will make available office space within its premises with internet connection and email access.

X- Bank Secrecy Declaration:

The Consultant should submit in his/her EOI a signed and stamped declaration, in which, as stipulated in "article (5) of the banking secrecy law dated 3/9/1956 and as stipulated in the resolution of the Council of Ministries no.4 dated 28/4/2020", the Consultant agrees to lift banking secrecy over the bank account used to deposit or transfer public funds related to this Contract, and which will be included as Contract Clause.

NOW THEREFORE THE PARTIES hereby agree as follows:

1. Services	<ul style="list-style-type: none">(i) The Consultant shall perform the services specified in Annex A, “Terms of Reference and Scope of Services,” which is made an integral part of this Contract (“the Services”).(ii) The Consultant shall perform the Services as per financial details of Annex B, “Consultant’s corresponding unit rates”.(iii) The Consultant shall submit to the Client the reports specified in Annex C, “Consultant’s Reporting Obligations.”
2. Term	The Consultant shall perform the Services during the period commencing <i>[insert starting date]</i> and continuing through <i>[insert completion date]</i> , or any other period as may be subsequently agreed by the parties in writing.

All expenses such as travel, airport transfer, site transfer, lodging, communication, meals, visa fee, etc....are deemed to be included in Consultant Monthly rate.

4. Project Administration

A. Coordinator.

The Client designates Mr./Ms. [*insert name and job title*] as Client's Coordinator; the Coordinator will be responsible for the coordination of activities under this Contract, for acceptance and approval of the reports and of other deliverables by the Client and for receiving and approving invoices for the payment.

B. Reports.

The reports listed in Annex C, "Consultant's Reporting Obligations," shall be submitted in the course of the assignment.

Monthly Progress reports will constitute the basis for the payments to be made under paragraph 3.

C. Timesheets

During the course of their work under this Contract, including field work, the Consultant shall be required to complete timesheets, or any other document used to identify time spent, as well as expenses incurred, as instructed by the Project Coordinator.

5. Performance Standards

The Consultant undertakes to perform the Services with the highest standards of professional and ethical competence and integrity.

6. Inspections and Auditing

The Consultant shall comply with the Bank's Anti-Corruption Guidelines and shall permit the Bank and/or persons or auditors appointed by the Bank to inspect and/or audit its accounts and records and other documents relating to the submission of the Proposal to provide the Services and performance of the Contract. Any failure to comply with this obligation may constitute a prohibited practice subject to contract termination and/or the imposition of sanctions by the Bank (including without limitation s (determination of ineligibility) in accordance with prevailing Bank's sanctions procedures.

7. Confidentiality

The Consultants shall not, during the term of this Contract and within two years after its expiration, disclose any proprietary or confidential information relating to the Services, this Contract or the Client's business or operations without the prior written consent of the Client.

8. Ownership of Material

Any studies reports or other material, graphic, software or otherwise, prepared by the Consultant for the Client under the Contract shall belong to and remain the property of the Client. The Consultant may retain a copy of such documents and software².

² Restrictions about the future use of these documents and software, if any, shall be specified at the end of paragraph 8.

9. Consultant Not to be Engaged in Certain Activities	The Consultant agrees that, during the term of this Contract and after its termination, the Consultants and any entity affiliated with the Consultant, shall be disqualified from providing goods, works or services (other than consulting services that would not give rise to a conflict of interest) resulting from or closely related to the Consulting Services for the preparation or implementation of the Project
10. Insurance	The Consultant will be responsible for taking out any appropriate insurance coverage.
11. Assignment	The Consultant shall not assign this Contract or sub-contract any portion of it without the Client's prior written consent.
12. Law Governing Contract and Language	The Contract shall be governed by the laws of <i>[insert government]</i> , and the language of the Contract shall be ³ <i>[insert language]</i>
13. Dispute Resolution⁴	Any dispute arising out of the Contract, which cannot be amicably settled between the parties, shall be referred to adjudication/arbitration in accordance with the laws of the Client's country.
14. Termination by the Client	<p>The Client may terminate this Contract with at least ten (10) working days prior written notice to the Consultant after the occurrence of any of the events specified in paragraphs (a) through (e) of this Clause:</p> <ul style="list-style-type: none"> (a) If the Consultant does not remedy a failure in the performance of its obligations under the Contract within seven (7) working days after being notified, or within any further period as the Client may have subsequently approved in writing; (b) If the Consultant becomes insolvent or bankrupt; (c) If the Consultant, in the judgment of the Client or the Bank, has engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices (as defined in the prevailing Bank's sanctions procedures) in competing for or in performing the Contract. (d) If, as the result of Force Majeure, the Consultant is unable to perform his Services for a period of not less than thirty (30) days; (e) If the Client, in its sole discretion and for any reason whatsoever, decides to terminate this Contract.

³ The law selected by the Client is usually the law of its country. However, the Bank does not object if the Client and the Consultant agree on another law. The language shall be English, French, or Spanish, unless the Contract is entered into with a domestic firm, in which case it can be the local language.

⁴ In case of a Contract entered into with a foreign Consultant, the following provision may be substituted for paragraph 13: "Any dispute, controversy or claim arising out of or relating to this Contract or the breach, termination or invalidity thereof, shall be settled by arbitration in accordance with the UNCITRAL Arbitration Rules as at present in force."

15. Termination by the Consultant The Consultant has the right to terminate this contract by not less than thirty (30) days written notice to the Client, such notice to be given after the occurrence of any of the events specified in the below paragraphs (a) to (c) of this Clause:

- (a) If the Client fails to pay any money due to the Consultant pursuant to this Contract hereof within forty-five (45) days after receiving written notice from the Consultant that such payment is overdue,
- (b) If the Client is in material breach of his obligations pursuant to this Contract and has not remedied the same within forty-five (45) days (or such longer period as the Consultant may have subsequently approved in writing) following the receipt by the Client of the Consultant notice specifying such breach,
- (c) If, as the result of Force Majeure, the Consultant is unable to perform his Services for not less than sixty (60) days.
