In reference to the Request for Proposal related to the “**Consultancy Services for the Technical Assistance for the Provision of Engineering and Consulting Services for Rubble Management in Quarry Sites**”, please note that the Council for Development and Reconstruction (CDR) hereby issues this Addendum to modify the RFP documents as follows:

1- Amendment to Section 2: Instructions to Consultants (ITC)- ITC Clause 11.1

ITC Clause 11.1 is amended as follows:

FROM: *"Participation of Sub-consultants, Key Experts and Non-Key Experts in more than one Proposal is permissible – No"*

TO: *Participation of Sub-consultants, Key Experts and Non-Key Experts in more than one Proposal is permissible - Yes, only if these are freelance individual key Experts".*

2- Amendment to Section 2: Instructions to Consultants (ITC)- ITC Clause 10.1 - Point (2)
ITC Clause 10.1 - Point (2) is amended as follows:

FROM: TECH-1: According to Lebanese law 324/2024 a stamp duty of 1,000,000 Lebanese Pounds must be paid for Public Tenders. TECH-1 should be completed, filled, stamped (Stamp 1,000,000 Lebanese Pounds) and signed.

TO: ~~TECH-1: According to Lebanese law 324/2024 a stamp duty of 1,000,000 Lebanese Pounds must be paid for Public Tenders. TECH-1 should be completed, filled, stamped (Stamp 1,000,000 Lebanese Pounds) and signed.~~ This condition (payment of a stamp duty) is not applicable to Foreign Consultants.
